William Mielke

William J. Mielke is President and Chief Executive Officer of Ruckert & Mielke, Inc., a consulting engineering firm with offices in Madison, Waukesha and Kenosha. Mr. Mielke graduated from the University of Wisconsin in 1971 with a Bachelor of Science Degree in Civil Engineering. He is a registered professional engineer, a registered land surveyor and a Diplomat in Environmental Engineering. During this same time the Village earned the League of Municipalities/ Foth & Van Dyke Good Government Award and a Governor's Award from the WI Economic Development Association. Currently, the Village is engaged in twelve shared services or consolidated government efforts ranging from equipment sharing to a merged police department. A student of lean management principles, Zuleger recently earned his green belt is Six Sigma.
